# **Purposes of Data Processing**

#### **Conservation Period**

The personal data collected is kept only as long as the relationship between CCIPF and the Member continues. After this period, the data will still be retained for the time necessary to comply with inherent legal and contractual obligations and when its conservation is necessary to guarantee the exercise of rights and duties resulting from these obligations.

#### **Personal Data Security**

CCIPF uses reasonable technical and organizational measures to protect the security and confidentiality of the personal data of the Member's contact persons, and regularly reviews and improves these measures to reflect legal developments and available technology.

#### **Data Subject Rights**
